- 1. As trustees of the Torgerson Family Trust. Each of the reporting persons serves as a co-trustee of the trust and is a current or future beneficiary thereof. Each of the reporting persons disclaims beneficial ownership of the reported securities except to the extent of his/her pecuniary interest therein.
- 2. Shares owned by 989677 Alberta Ltd., of which Lance Torgerson owns, indirectly, 100% of the voting shares. Tammy Torgerson disclaims beneficial ownership of the shares, which are beneficially owned, indirectly, by Lance Torgerson, her spouse.
- 3. The Preferred Shares can be converted by the issuer at any time if the 15-day volume weighted average price of the Common Shares is equal to or exceeds the Conversion Price; the holders of the Preferred Shares will have the right to convert the Preferred Shares into Common Shares at any time after April 2, 2020.
- 4. The Preferred Shares mandatorily convert after five years from the date of issuance.
- 5. The Preferred Shares are convertible into the number of Common Shares at a rate of 3,030.3030 Common Shares per each \$10,000 of Liquidation Preference. The Preferred Shares have an initial Liquidation Preference of \$10,000 per share, which amount may be increased in connection with the accrual of dividends or the payment of in-kind dividends.
